- Launched 28/10/2019 (until 27/10/2023)
- More than 200 members of network from over 38 European countries and International Partner Countries (IPCs)
- Aim of COST Actionto integrate and strengthen capacity in burden of disease assessment across Europe and beyond

Five working groups (WG) established as part of COST action Burden of Disease Network


- WG1: Non communicable diseases and injuries

Fostering methodological advances and technical capacity building

- Key purpose of burden-eu bring together experts and expertise across different domains to consolidate the current scattered burden of disease landscape
- Achieved through the following activities:
 - Development of a continuously updated database of burden of disease studies in Europe
 - Development of reporting guidelines for burden of disease studies, and DALY calculations in particular
 - Development of a standardized roadmap for national burden of disease studies
 - Development of a DALY calculation checklist
 - Development of standardized and open access training material, including massive open online courses (MOOCs)




Building capacity: Training Schools

- Organised on Action related research topics and provide dissemination opportunities for an Action's activities.
- Aim to strengthen capacity in burden of disease assessment across Europe.
- Provide intensive training in basic and emerging research topics within the organisations involved in the Action.
- Participants are mainly, but not exclusively, young researchers involved in the Action.
- Duration normally between three days and two weeks.

Building capacity: Burden eu training schools:



- Carried out poll among COST Action members for topics to be covered in Actions first training schools
- First training School
 - General concepts of BoD
 - Covering YLL, YLD, theory and calculation
- Second training School
 - Advanced concepts of BoD
 - Risk factors: Forecasting: Health Impact Assessments
- Mix of lectures and practical exercises
- To be held in Belgrade, Serbia February/March 2021
- The training schools will be organized back-to-back over 5 days

Building capacity: Short-term Scientific Missions (SSTMs)



- Aim: to support individual mobility and strengthen the existing networks and fostering collaborations by allowing scientists to visit an institution in another participating COST country
- SSTMs hould contribute to the scientific objectives of the burden-eu action
- STSMs in general aim to be a focus for researchers wishing to contribute to the tasks of Working Groups (WGs).
 - Estimating the burden of diabetes in Malta (Malta/Belgium) Non communicable disease working group
 - Methodological exchange on BoD topics- comorbidity, severity distributions (Germany, Belgium, Scotland and Netherlands) – Methods working group
